

# Funding for agricultural and forestry demonstrations




## Latvia

- The Ministry of Agriculture announces the procurement of agricultural and forestry demonstrations.
- Applicants must identify the needs of the industry for the selection of topics.
- Open to both public and private consultants, as well as scientific institutions.
- The purpose of the event is to demonstrate the advantages of a new agrotechnical technique, technological process, crop or animal breed, which have been tested in research and reflect at least two variants - the existing standard technique and the new technique.

# Advisor CPD in Ireland – eLearning Modules

- Development of 5 x 2.5 hour eLearning modules for advisors.
- Ministry established a Learning Platform for advisors.
- Teagasc, working with eLearning company, designed 5 modules on biodiversity, climate action, soil health, farm health and safety and water quality.
- All FAS advisors were obliged to complete the training.



# Mandatory Participation of Advisors in EIP-OGs

## Austria

- Participation of Advisors in projects from operational groups in frame of the EIP-Agri is mandatory. Advisors are part of the OG and can get respective funding for their contribution.
- This supports cooperation between research and advisory services and practice; speeding up transfer from science to practice and increasing practice relevance of research
